Dan graduated Rutgers University and Dickinson Law School, and served in the United States Army in Vietnam. Dan's law practice focused on creditor rights and remedies. His law career spanned more than 45 years, including service as a part-time Cumberland County Assistant Prosecutor and as the Vineland Municipal Court Judge.

Dan and his wife Ruth headed the Cumberland County Bar Foundation Golf Tournament for many years, raising a truly extraordinary amount of money for the Foundation. In addition to being a golfer, Dan was the reigning paddleball champion in Vineland in the early 1980s. He was in the process of retiring when he unexpectedly passed away on June 23, 2017, at the age of 73.
